# SECTION 11 : TOXICOLOGICAL INFORMATION

# 11.1. Information on hazard classes as defined in Regulation (EC) No 1272/2008

Exposure to vapours from solvents in the mixture in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on kidney, liver and central nervous system.

Symptoms produced will include headaches, numbness, dizziness, fatigue, muscular asthenia and, in extreme cases, loss of consciousness. Repeated or prolonged contact with the mixture may cause removal of natural oil from the skin resulting in non-allergic contact dermatitis and absorption through the skin.

May have reversible effects on the eyes, such as eye irritation which is totally reversible by the end of observation at 21 days. Splashes in the eyes may cause irritation and reversible damage

Narcotic effects may occur, such as drowsiness, narcosis, decreased alertness, loss of reflexes, lack of coordination or dizziness.
